\$21 Million in Civil Legal Services Funding is in Jeopardy

The federal Legal Services Corporation (LSC) is threatened with elimination by the Trump administration.

A January 19, 2017 article in *The Hill*, reported that the Trump Administration would intensify a decades-long effort to eliminate LSC funding. This plan is based on the previous recommendations of President Reagan in the 1980s, the Newt Gingrich Congress in 1995 and, more recently, a 2005 Heritage Foundation report (from a committee chaired by then-Congressman Mike Pence), all recommending the elimination of LSC. Since that initial warning more recent reports, including a February 17 article in the *New York Times*, have confirmed that this is a real and urgent threat.

If LSC funding is indeed zeroed out, it would mean the loss of approximately \$21 million in federal funding for the seven legal services programs in New York State that receive LSC funds.

LSC-funded programs provide free civil legal services to all the counties of the State, serve more than 220,000 low income New Yorkers annually, and employ more than 1,000 staff members. The loss of \$21 million in LSC funding would be catastrophic for this service-delivery system.
